Please note that Pyrford International Ltd is a subsidiary of the Bank of Montreal (BMO) Financial Group. BMO previously disclosed a total deemed interest of 6.19% in the shares of the issuer on 23 February 2021. The transaction that took place on the 24 May 2021 now gives Pyrford a direct interest of 5.018% in the shares of the issuer, there are no other relevant BMO subsidiaries that individually hold more than 5% in the shares of the issuer.

The percentage of shareholding is calculated based on the Company's total issued share capital of 2,167,411,663 (excluding 11,250 Treasury Shares) as at 24 May 2021.
